Contact Information

The first four columns include the company name, contact person, phone number and Web site or e-mail address.

Types of Vendors

The types of vendors listed in this column are:

Billing Agent	Billing Agents offer Medi-Cal claim filing services to Medi-Cal providers and provide a wide variety of other products, services and fee structures.
Clearinghouse	Clearinghouses supply software that allows providers to electronically transmit claims (to the clearinghouses) and transmit claims to Medi-Cal (for providers that typically submit a large volume of claims).
Electronic Attachment Vendor	Electronic Attachment Vendors are authorized third-party vendors that submit electronic attachments to Medi-Cal on the provider's behalf.
Other	Other transaction types or the transaction type was not indicated.
Software Vendor	Software Vendors sell software products that allow providers to enter and submit Computer Media Claims (CMC) electronically.

Types of Transactions

This column indicates the HIPAA-compliant transactions the company submits, or has the ability to submit to Medi-Cal.

837P	ASC X12N 837 v. 5010 Professional (837P) electronic transactions.
Electronic Attachments	Electronic attachments for 837I and/or 837P transactions.
PA	NCPDP VD.0 PA transactions. Providers may submit an electronic Treatment Authorization Request (eTAR) by using a third-party vendor, or a vendor's software, without using online Transactions Services for Medi-Cal.
RTIP	Providers may submit a pharmacy claim using the Internet and receive an instant response to verify if an individual claim was either paid or rejected for each claim submitted.
SCPI	Supplemental Claims Payment Information (SCPI) is an electronic file similar to Remittance Advice Details (RAD) codes. Files are generated on a weekly basis and available to download from Transaction Services on the Medi-Cal Web site.
CHDP Claim	Electronic submission of the Confidential Screening/Billing Report (PM 160) for the Child Health and Disability Prevention (CHDP) program.

**Special Segments/
Claim Types**

This column indicates which segments within the claim transactions may be submitted by a particular vendor, billing agent, or clearinghouse.

BM	Attachments sent by standard mail.
Crossover	Crossover indicates that the submitter is authorized to electronically bill claims that automatically cross over from Medicare to Medi-Cal for payment (also called "Crossover Claims").
FX	Attachments sent using a fax machine.
NTE	The notes (NTE) segment is used with the 837I/837P transaction. It is a situational segment used to convey the description for the primary diagnosis code previously submitted in the CMC <i>Remarks</i> field.
PWK	The paperwork (PWK) segment is a situational segment used with 837I/837P transaction to match the claim to its attachments and/or other types of supporting documentation. Currently, Medi-Cal only accepts attachments at the claim level and not at the service line level.
