## Presumptive Eligibility rau Cov Poj Niam Cev Xeeb Tub yog dab tsi (PE4PW)?

PE4PW yog ib txoj kev pab kho mob tam sim ntawd mus ib ntus uas muaj feem rau kev xeeb tub rau cov poj niam cev xeeb tub uas tau nyiaj tsawg, suav kev rho me nyuam thiab kev nchuav me nyuam tib si thiab. Feem ntau kam them rau kev mus cuag kws kho mob, chaw kho mob, thiab chav kho mob thaum muaj xwm ceev. Kam them rau cov tshuaj qab los uas noj thaum cev xeeb tub (prenatal vitamins) thiab cov tshuaj noj feem ntau. PE4PW TSIS them rau cov nqi yug me nyuam tim tsev kho mob los sis lwm cov kev kho mob thaum pw tim tsev kho mob. Koj yuav tsum tau teev ib daim ntawv thov kev pab kom thiaj li tau kev pab them nqi yug me nyuam.

## Leej twg tsim nyog rau PE4PW?

Ib tug poj niam twg uas xav tias nws cev xeeb tub thiab nws tsev neeg cov nyiaj tau tsawg dua li qhov nyiaj teev tseg yuav tsim nyog rau PE4PW. Ib tug poj niam cev xeeb tub yuav suav tias yog ob leeg los sis coob tshaj ntawd, nyob ntawm seb yuav yug pes tsawg tus me nyuam. Kev pab them nqi hauv PE4PW pib hnuv rau npe koom.

## Kuv yuav thov PE4PW li cas?

Koj yuav tsum tau thov los ntawm ib qho Chaw Muab Kev Pab Tsim Nyog uas muab kev koom tes. Nug koj tus kws kho mob los sis qhov chaw kho mob seb lawv puas muaj qhov kev pab ntawd los sis mus rau ntawm [www.dhcs.ca.gov/services/medi-cal/eligibility/Pages/PE.aspx](http://www.dhcs.ca.gov/services/medi-cal/eligibility/Pages/PE.aspx) es mus xyuas daim ntawv teev tag nrho cov chaw muab kev pab.

## Kuv yuav tau kev pab them nqi hauv PE4PW mus ntev npaum li cas?

Kom txog thaum koj daim ntawv thov kev pab them nqi kho mob tag nrho uas them taus ntawd, nrog rau Medi-Cal, raug pom zoo rau los sis tsis pom zoo rau tso. Koj yuav tsum tau xa daim ntawv thov kev pab tag nrho mus kom thiaj li tau txoj kev pab PE mus txuas ntxiv.

Medi-Cal xav kom siv [Text4Baby](http://Text4Baby), ib txoj kev pab dawb 100%. Text4baby yuav xa cov lus qhia kom nco ntsoov txog lub sij hawm teem tseg nrog ib tug kws kho mob, cov lus qhia txog kev soj ntsuam mob thaum cev xeeb tub, me nyuam txoj kev loj hlob, cov tsos mob uas qhia tias txog sij hawm yuav los so, kev pub niam mis rau me nyuam noj, kev noj haus thiab ntau yam ntxiv uas yuav xa ncaj qha tuaj rau hauv koj lub xov tooj ntawm tes. Nws yog DAWB xwb, txawm tias koj tsis muaj kev sau ntawv hauv koj tus nqi xov tooj. Yog xav sau npe koom, ntaus lo lus BABY los sis BEBE mus rau 511411 los sis mus online ntawm [www.text4baby.org](http://www.text4baby.org). ## Yuav ua li cas yog tias kuv tau txais cov ntawv kom them nqi rau cov kev pab uas kuv tau txais?

Yog tias koj tau cov kev pab uas PE4PW txoj kev pab tsis them rau, tej zaum Medi-Cal li niaj zaus (regular) yuav them rau cov nqi ntawd. **Thov Medi-Cal li ntawm pib lub hlis ntawm hnuv tau txais kev pab kho mob (TSIS yog hnuv tim hauv daim nqi—li ntawd tej zaum yuav lig zog lawm).** Teb tias “muaj” rau nqe lus nug hauv daim ntawv thov kev pab hais txog cov nqi kho mob hauv pib lub hlis tas los, txawm tias koj tsis tau txais ib daim nqi li. Yog tias koj tsis xav tau kev pab tuav pov hwm tom qab PE4PW vim tias koj nchuav me nyuam lawm los sis vim tias muaj lwm yam, koj yeej yuav tsum tau thov thiab kos tias “muaj” rau qhov kev pab them nqi mus pib lub hlis.

## Yuav ua li cas yog tias kuv twb them tas cov nqi kho kuv lawm?

Yog tias koj thov kev pab thiab tau Medi-Cal, hais kom koj qhov chaw muab kev pab kho mob xa daim nqi mus rau Medi-Cal thiab kom lawv muab koj qhov nyiaj rov qab rau koj. Yog tias qhov chaw muab kev pab kho mob tsis kam ua li ntawd, hu los sis sau ntawv mus rau Medi-Cal Program hauv Sacramento hais txog *Conlan* Beneficiary Reimbursement Program.
